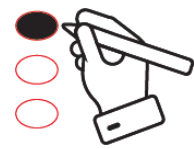

Voter-Nominated and Nonpartisan Offices

All voters, regardless of the party preference they disclosed upon registration, or refusal to disclose a party preference, may vote for any candidate for a voter-nominated or nonpartisan office. The party preference, if any, designated by a candidate for a voter-nominated office is selected by the candidate and is shown for the information of the voters only. It does not imply that the candidate is nominated or endorsed by the party or that the party approves of the candidate. The party preference, if any, of a candidate for a nonpartisan office does not appear on the ballot.

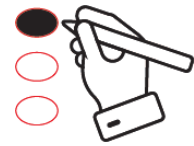

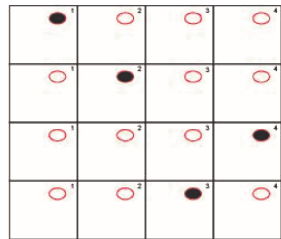

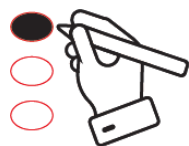

MEASURES SUBMITTED TO THE VOTERS / 提交選民投票的提案

STATE PROPOSITIONS / 州提案

1 CONSTITUTIONAL RIGHT TO REPRODUCTIVE FREEDOM. LEGISLATIVE CONSTITUTIONAL AMENDMENT. Amends California Constitution to expressly include an individual's fundamental right to reproductive freedom, which includes the fundamental right to choose to have an abortion and the fundamental right to choose or refuse contraceptives. This amendment does not narrow or limit the existing rights to privacy and equal protection under the California Constitution. **Fiscal Impact:** No direct fiscal effect because reproductive rights already are protected by state law.

生育自由的憲法權利。立法性憲法修正案。修正加州憲法，以明確包括個人生育自由的基本權利，其中包括選擇墮胎的基本權利以及選擇或拒絕避孕用品的基本權利。此修正案並沒有縮小或限制加州憲法規定的現行隱私權和平等保護權。財政影響：由於生育權已經受到州法律的保護，所以沒有直接的財政影響。

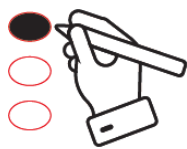
