A discussion of housing issues will head the agenda at the meeting of Neighbors of the Excelsior (NOTE) on March 29. The meeting will start at 7:30 and will be held in the clubhouse of the Excelsior Playground at the corner of Russia and Madrid.

New building guidelines

New zoning and building regulations proposed by the City Planning Commission will be presented at the NOTE meeting. followed by a discussion and vote on special guidelines for the Excelsior. See stories on page 2 & 3 for more details.

Historic home threatened by demolition

A home which has stood in the Excelsior since 1880 -- and withstood two major earthquakes -- is being threatened by demolition by developers.

The home, pictured below, is at 699 Paris Street and is a beautiful example of a false-front Victorian. It has been kept in very good condition but its troubles stem from the fact that it stands on a double-wide lot. Developers want to tear the house down, subdivide the lot into two, build two new houses and put them up for sale.



NOTE calls for special Excelsior building rules

In response to the city's proposed permanent building controls (see story on page 3), NOTE wants to propose to the City Planning Commission special building rules for the Excelsior to protect the unique character of our neighborhood.

Over the past two years, the building committee of Neighbors of the Excelsior (NOTE) has discussed the effect of city building rules on area homes. The committee, headed by Bill Martin, has drafted a proposal which reflects the special needs of our area.

The committee's proposed special rules will be discussed



Neighbors of the Excelsior boundaries have been expanded to include streets north of Silver Ave. The area now extends from Mission St. to McLaren Park and from Geneva Ave. to Highway 280. at the NOTE general meeting on March 29, 1990. Members will vote on the proposed Excelsior rules. After the vote, the proposal will be presented to the City Planning Commission. The building committee is proposing the following:

1. Height limit: The Planning Commission proposes a maxi-

flagrant disregard for city building rules. NOTE proposes that more effective penalties be applied to builders who ignore the rules.

6. City fees. The only way for neighbors to challenge building plans is to request a "discretionary review" hearing by the Planning Commission. At present a

mum height limit of 24' for 2story houses, 32' for 3-story houses and 40' for 4-story houses. NOTE is proposing that the height limit be 32' in the two Excelsior blocks which are predominently 3-story homes, and 24' for the remainder of the area.

- 2. Open space. The Commission is proposing that every home can have a 12' extension into the backyard, though the entire structure cannot take up more than 75% of its lot area. NOTE is proposing that there be a backyard of at least 45% of the lot in order to preserve our existing open space.
- 3. Parking. NOTE is proposing that new houses be required to include one interior parking space for every 750 square feet of living space.
- 4. Design standards. NOTE supports the City Planning Department's Design Guidelines. At present, all new buildings and alterations must follow the guidelines. Basically the guidelines reinforce Proposition M rules that building must conform to the existing character of the neighborhood.
- 5. Enforcement. Rules are one thing, enforcing them is another. One of the biggest problems is

neighbor must pay \$50 to ask for this hearing. The Board of Supervisors is suggesting that the amount be raised to \$150. NOTE feels that this is too expensive for most Excelsior residents.

7. Notification. NOTE supports existing rules that require notifying neighbors within 300 feet. when new building, alterations or demolitions are proposed. The Commission's new guidelines limit notification to neighbors on either side of the building site.





The Excelsior was first settled in the 1880s and the house at 699 Paris was among the first built. There are only a few of the original homes left to remind us of the area's history.

Planning Commission approval needed

The developers' scheme must be approved by the City Planning Commission. Several neighbors and Neighbors of the Excelsior (NOTE) are opposed to the demolition. In addition, NOTE is concerned about whether the new houses will be designed to fit into the character of the neighborhood.

New trees beautify the Excelsion

You may have noticed that trees have been popping up all over the Excelsior neighborhood. In fact, over the past year, neighbors have helped each other plant over a hundred trees in front of area homes. Last July, 54 trees were planted in the central Excelsior area. In January, 27 were planted in the southern part of the neighborhood and another 27 were planted in the northern part.

Friends of the Urban Forest

Neighbors have the help of the Friends of the Urban Forest, a non-profit group, which pays



half of the cost of planting each tree. FUF also buys and delivers the trees, hires contractors to break up the concrete sidewalk and dig a hole, obtains city permits, sends volunteers to help plant and gives advice on the care of the tree. FUF can also advise you on the best tree for your location.

Planting day is lots of fun

Besides getting a beautiful tree in front of your house, the planting is a good way to meet your neighbors. Everyone gets to participate, even children. At the end of the planting, everyone sits down to a well-deserved potluck lunch.

How to Get a Tree in Front of Your House

City proposes new building rules

Two years ago, neighbors in the Richmond district of San Francisco began protesting against the large numbers of perfectly good houses being demolished to make way for newer, more expensive buildings. When many other neighborhoods joined the protest, the city responded with "interim controls" to make the building permit process more responsive to neighbors' concerns.

The "interim controls" will end soon and must be replaced by permanent changes in zoning and building rules. The City Planning Department is drafting the new rules for presentation to the City Planning Commission.

The new rules will redefine what kind of demolitions, new construction and alterations are permitted by the city. The city wants a set of guidelines which automatically apply to every housing situation. Currently, many permits are considered individually before the City Planning Commission, allowing neighborhood input but leading to a case backlog. The proposed new rules will reduce neighbors' input.

Neighbors of the Excelsior feels that generic rules don't allow for differences in neighborhoods. Because the Excelsior is unique, NOTE is proposing special rules in conjunction with the permanent controls to protect the unique character of our area.

The special rules, which are described on page 2, will be reviewed at the NOTE general meeting on March 29. Come to the meeting and discuss how the new rules will affect you, your property and your neighborhood. Or, call Bill Martin at 587-5730 if you want to make suggestions about the new controls.

targeted for hazardous waste facility

Would you like a hazardous waste incinerator within a few miles of your house? Though it's not a pleasant thought, it might become reality.

Because of state laws, San Francisco soon must finalize a hazardous waste disposal plan. The Board of Supervisors appointed a Hazardous Waste Advisory Committee to develop the plan.

First plan rejected

Their first plan, made public last fall, was denounced by city residents and the developer withdrew his application. The developer proposed to place the facility in the southeastern part of San Francisco and to import hazardous wastes from other parts of the state.

Because of public outcry, the membership of the committee was broadened to include more community representatives. The committee meets every Wednesday at 6:30 pm at 101

St., Room 300. The committee is now redrafting their plan.

What do you think?

How do you think the city should handle hazardous wastes? Should the city have an incinerator? Should we accept wastes from other cities?

Or should our plan concentrate on learning how to reduce the amount of toxic wastes from industrial and household activities? And explore ways to recycle hazardous wastes?

Your ideas are important. One way to express your views is to attend the Hazardous Waste committee meetings and tell them what you think.

Toxic Waste Forum

You can also attend the Toxic Waste Forum on April 19 at 6:00. City representatives and neighborhood groups will speak.
