The shuttle will connect major hotels and 10 shopping and dining areas and is scheduled to begin in February 1990, in time for the beginning of the next major convention/visitor surge.



### Shoppers' Shuttle &

Exciting news! Our long-awaited shoppers' shuttle service appears to be nearing reality. In fact, it now has an official licensed name -- D.A.S. BUS (Dining And Shopping Bus), and will be managed by Showbus, Inc.

It is estimated that service will begin in February 1990, with a passenger capacity of over 30,000 shoppers per month. Plans call for a route with 10 shopping locations, including Union Square, Embarcadero Center, Ghiradelli Square, and North Beach. Tickets will be sold at \$5.00 for adults, \$3.00 for children and seniors, and will provide for a full day of shopping.

D.A.S. BUS will operate daily from 10 am-10 pm with two to three 33-passenger German high-tech buses in service at 15 - 25 minute intervals. Preliminary research shows a strong interest from hotels and conventions as well as locals. Videos in hotel room, brochures, and advertisements will support the service. On D.A.S. BUS, passengers will be treated to live entertainment, professionally produced videos showcasing each shopping area, and live commentary.

This entire program has been produced as a result of the efforts of the Union Street Promotional Program in conjunction with Jim Hollenbeck and Judy Jacobs of IDEA, Ltd. And, this is just one of the many exciting programs planned for 1990. For those of you who are participating in USA's promotional program, thank you! # Safe Xmas

The San Francisco Fire Department requires regulations be followed regarding the use of Christmas trees in retail stores, hotels, and office buildings, including:

- 1. Trees and wreaths must be treated and maintained in flame retardant condition, and tagged as so certified.
- 2. Flame retardant must be applied by a certified applicator registered with the State Fire Marshal.
- 3. Candles are prohibited on Christmas trees and wreaths.
- 4. All Christmas tree butt's or bottom's must be immersed in at least 2 inches of water at all times. Just before immersion, the trunk must be cut off at least one inch above the original cut.
- 5. No readily combustible materials shall be placed on, under or within four feet of the maximum horizontal projection of any Christmas tree.
- 6. No Christmas tree or decoration shall be displayed in such a manner as to impede or affect any exit.
- 7. No Christmas tree shall be displayed for a period of more than 30 days after the date of a required flame retardant application.

8. (Sec. 27.10) Electrical Decorations:
Approved electrical decorations and wiring appurtenant thereto which are displayed...may be installed and maintained on Christmas trees, live Christmas trees and on Christmas decorations; provided that all such electrical decorations and wiring which are displayed during the Christmas Season shall be certified as safe for the displayer's designated use by a licensed electrical contrator within thirty (30) days of the beginning of each Christmas Season. For the purposes of this subsection, "Christmas Season" shall mean from the Monday immediately preceding "Thanksgiving" to the including January 15th of the following year.

Any certification required under this Section shall be made by letter on the business stationery of such electrical contractor. Any such certification shall include all of the following:



Date of Certification
Licence number of the Contractor
Business address of the Contractor
Statement of the type and quantity of
materials certified.
Designated use of the materials certified
Signature of the contractor.

# Shoplifting Alert/Typs

The Christmas season means more shoppers and, unfortunately, more shoplifters. Review these tips from SFPD Officer **Ben Vigil** to minimize your losses:

- 1. 80% of all shoplifting is "spur of the moment." Someone sees an opportunity to steal, and does so. Alert clerks can make a big difference.
- 2. 20% of shoplifting is done by professionals. If you suspect someone is a "pro," let them know you are aware that they are in your store. Simply approaching them and asking if you can help them is a good beginning. Keeping a close eye on them may result in their leaving empty-handed and finding an easier mark.
- 3. Beware of teams (two or three people) of professional shoplifters who enter your store together. Usually, one of them keeps store clerks occupied while the other(s) steals. Alert clerks to this scam, and see that they maintain close contact with both "shoppers" if they suspect a crime is in progress. Juveniles also often divert the attention of clerks while friends are shoplifting.
- 4. Shoplifters often carry empty shopping bags (to fill with your goodies) or many shopping bags. Also, persons wearing big, bulky overcoats -- especially when the weather doesn't call for it --might be looking for "freebies." You may want to check bags as shoppers enter your store.
- 5. Keep expensive items away from main entrance to avoid quick rip-offs (grab and run). Lock up jewelry and other expensive, easily stolen items.
- 6. It is illegal to search a person, though you may search their packages. While you need to be aware of the laws to avoid liability and bodily harm, you may want to confront a shoplifter in your store if you're sure they've stolen items from you so that you can retrieve those items. This is a judgement call, as professionals may try to resist your efforts. By retrieving the stolen items before the person leaves your store, you cannot have them arrested -- but you have your merchandise. If shoplifters are caught after they leave your premises, they can be arrested.

In all cases of shoplifting in progress, call 911.

USA Meeting Notes

The USA General Meeting, held on October 25 at the Hafez Cafe (2001 Union St.), was attended by 40 business owners expressing interest in earthquake recovery. Marina Merchants Association President Harold Hoogasian (Hoogasian Flowers) reported that most merchants were operating regularly but that some restaurants still did not have gas service. He introduced Dave Ish. publisher of the Marina News and The New Fillmore, who offered a full page ad space in his newspapers and was getting commitments from other San Francisco papers to print a statement from both USA and the Marina that we are open for business. This statement should give confidence to the consumer that they can return to our side of town. Thanks, Dave.

A report on USA's Advertising & Promotion Program was given by IDEA representatives Jim Hollenbech and Judy Jacobs. They encouraged businesses to go ahead with scheduled events and promotions. The Arts Alive Promotion was proceeding as well as the Christmas "Season of Entertaining" Program. Funds are needed for a shopping shuttle (see article on page 2). IDEA is continuing to solicit local businesses to become part of the "Let's Meet on Union Street" promotions for 1990. A new brochure and umbrellas bearing the new logo are currently being designed.

It was suggested and agreed that a portion of the proceeds from the Arts Alive opening be donated to the Marina Earthquake Relief fund.

Captain Denis Martel, of the SFPD Northern Station updated the audience on post-earthquake police matters. He reported that the special Christmas beat patrol will be visible and that the SFPD crime prevention program is operational. Police officers will be visiting our merchants with advice on crime prevention.

# Building Controversy

After meeting with USA Planning & Zoning Committee, an understanding to preserve the facade of the classic box style building at 2253 Union Steet was reached.

Building owner Dr. Stan Dinchto was granted a permit to renovate this structure into a 15-room Bed & Breakfast Inn in 1986. Dinchto did not build the B&B, and applied for a revised usage and design.

Hearings were held by the SF Department of City Planning to ensure the historic building, protected by Proposition M and Union Street's Design Guidelines, would be preserved.

This past April, Dr. Dinchto applied for a modification of the approved plans, requesting he be permitted to extend the rear of the building by 10 feet. Dinchto declined to meet with USA's Planning & Zoning Committee and residents prior to the SF Planning Commission hearings on these proposed changes. USA and residents then went to the Department of City Planning and secured the blueprints to review those changes. When it was determined that some of the modifications had been made prior to a permit being granted, USA requested a "Discretionary Review," which is a controversial process in which special hearings of the Planning Commission review in detail a specific project's progress, and listen to conflicting opinions on the project.

The SF Planning Commission voted 4 to 2 to disallow the changes made to the first and second stories of the building on the grounds that they would not be in keeping with the character of the neighborhood, that the encroachment into the "green belt" behind the building was too great, and the height exceeded the original permit. The Commission allowed the basement enlargement. It futher mandated that the developer adhere to historic design and use compatible materials in the join USA, call 441-7055. new additions of windows, trim, moldings, etc., and that work on the project not begin before 8:00 a.m. No work is allowed on Sunday.

USA wishes to thank the members of our Planning & Zoning committee for volunteering their time to ensure the character of historic Cow Hollow is preserved and maintained. Page 6
