During the interim, three volunteers will concentrate their efforts on the Traffic and Parking Department, Arts Commission, and internal post office operations. 

General Meeting Update

Over 40 business people were on hand to discuss and share recent events in the area at our General Meeting on October 24th.

After the President's greeting and a self-introduction by attendees, Executive Director Lesley Leonhardt reported on meetings she had attended regarding post office problems and crime in the city. She invited interested people to attend the Parking and Traffic Authority meeting in our neighborhood at the Marina Middle School that evening at 7:30pm. (see report elsewhere in the news on the meetings)

President Beckman encouraged businesses to donate \$10 towards the lighting of the Palace of Fine Arts. All monies collected would be given by the USA to support the beautification of a San Francisco landmark enjoyed by many.

Representative Orlandus Waters of Provident Central Credit Union discussed new benefits for individual financial planning and tax information now available from Provident.

Officer Ben Vigil of the SFPD presented an update on crime in our area. Unfortunately, robberies are up 10% city-wide, a rape took place on Filbert Street Oct. 6th. However, no homicides have occurred. He told of plans to place undercover beat officers in our neighborhood during the Christmas Holidays to help eliminate shoplifting.

A discussion of ad and promotion venues followed. Perry Thompson of Pasand informed everyone, that the City has changed it's policy regarding the number of patrons allowed in dining/bar lounge entertainment businesses. The Fire and Police Departments have cut back the allowable number of patrons drastically and it may prove to have a negative impact on small businesses. He spoke also of a moratorium on new entertainment licenses being issued, even to existing locations that will be needing them when the business changes hands. This change in City policy amounts to major down zoning brought upon us by residential pressure from the neighborhood. It was agreed by those attending that the Association should defend it's businesses and proceed toward negotiations with the City on compromise measures benefitting both the residents and business.

Jim Hollenbeck spoke directly regarding the mood of retailers in major downtown and mall shopping centers. He said we needed to jointly work towards a Victorian Christmas Theme that

offered a different and more warm approach to holiday shoppers to U.S.

The meeting adjourned at 10:15 pm. Thanks to Cal Bordovaro for hosting the meeting.
