Over 150 businesses have signed up for the North Beach "Guide to Shops, Dining, Entertainment and Services". Typesetting, printing and distribution are expected to take several weeks. Therefore, it is imperative that we get your checks and completed applications right away. Herb Smith is visiting every merchant in North Beach. Not counting all of the second floor businesses, there are at least 400 of you. Time is of the essence! Tourist season is rapidly approaching! So please cooperate and let's get the show on the road.

Once again, the brochure will be approximately 11" x 24" and will be printed in two colors on high quality glossy paper. There will be a map on one side strongly emphasizing availability of parking at the various lots throughout North Beach. (It's difficult to believe that we actually have underutilized lots!) The cost is \$60 per business. North Beach has never had a brochure like this before. \* Coit Liquors, 585 Columbus, has been hosting wine tastings for the past five years. Because wine tastings require a large restaurant space that is closed to the public in the evenings, it was difficult for them to find a North Beach location, so they held the tastings at Opts, a south of Market restaurant on Monday nights. Recently, they moved to Cafe Francisco at 2161 Powell, back in the neighborhood but soon found that the attendance at the tastings had grown too large for the 45 seat cafe. On March 11th, there will be one more tasting at Cafe Francisco 7:30 pm, Simi Winery, and then it's off to higher ground on Nob Hill, Vanessi's at 1177 California and on April 13th, 7:30 pm, the tasting will be California Pinot Noirs. \* VICTORY FOR BROADWAY! When the city planners developed the Neighborhood Commercial Zoning package, Broadway and North Beach were treated as two separate zoning districts. The proposed controls forbid new billboards in North Beach but allow them along Broadway. The problem was whatever happens on Broadway impacts North Beach and if no new billboards were to be allowed in North Beach, wouldn't logic dictate there would be a rush to erect as many billboards as possible along Broadway, especially as it links Hwy. 280 with 101 North.

However, one of our organization's goals is to improve Broadway's appearance and additional billboards are not going to help.

Three hearings took place at City Hall the week of February 23rd and three times voices were heard asking that the proposed controls be amended to include no new billboards along Broadway.

Then words came rushing along the grapevine that Sup. Carol Ruth Silver wanted to weaken billboard controls and was about to propose new legislation on Monday, March 1st to that effect. Hasty letters were sent to her with copies to everyone involved at City Hall urging that there be no new billboards in North Beach and along Broadway as well. Carol Ruth's proposed legislation acknowledges our requests and states: "New general advertising signs (i.e. billboards) are to be prohibited in the Broadway, Castro, West Portal, Outer Clement, Haight, North Beach, Hayes-Gough, Sacramento, Union, 24th & Noe Valley Districts".

Even though the proposed legislation still has to be presented at numerous hearings, we can count this an early victory. Thank you, Carol Ruth.



\* Sprucing up! Tony's Hair Studio, 847 Columbus, Knitz, 1429 Grant Avenue and Cafe Italia, 708 Vallejo, are spring cleaning, redecorating and repainting.

\* One Hour Martinizing, formerly at 930 Columbus, has relocated at 757 Lombard in the space most recently occupied by Rege Wines, the wine company that locked horns with comedian Robin Williams and his Reggae skit. Owner is Ray Ra.

\* On February 23rd, the Small Business Advisory Commission hearing upheld the recommendations made to them by the Commercial Leasing Task Force. The proposals now go to the full Board of Supervisors and the mayor for approval. These proposals are an innovative approach to our commercial rent woes and in no way support the notion of commercial rent control.

The salient parts of the proposed legislation are this: that it is the responsibility of the commercial tenant to notify his landlord one year in advance of the lease's expiration. The landlord has three months in which to respond to his tenant and to announce his intentions with regard to the lease. If the landlord ignores the tenant, the lease is extended accordingly. If the landlord insists on unfairly escalating the rent, then the tenant will have nine months in which to negotiate and/or relocate.

Other parts of the recommendations involve education of lessors and lessees with regard to changing ordinances and zoning, how to negotiate, etc., detailed research study by the commission and monitoring.

Once again, San Francisco leads the country in innovations and hopefully this proposed legislation will ameliorate many of the problems we are now experiencing in the commercial sector, especially the suddenness of huge rent increases, which don't allow time for adjustment or relocation.

The 36 member task force represents a cross section of business people and residents from around the city. Although the recommendations have some details that still need ironing out, we owe a lot of thanks to local people on that task force: Chris Martin of The Cannery, Jane Winslow of Telegraph Hill Dwellers, Jim Stevens of North Beach Neighbors, Louis Martinelli of Florence Ravioli Factory and Brad Paul, a North Beach resident, as well as with the North of Market Planning Coalition.
